Intra-Community Transfer Fee	\$500	One time, due at move-in	Required
Late Fee	5% of Base Rent	Monthly	Required
Lease Buy Out	1-Month Rent	One time, due 3 days after notice is received	Required
Legal/Eviction Fees	Variable	One time, per occurrence	Required
Returned Payment Fee (NSF)	\$20	One time, per occurrence	Required
Security Deposit - Additional (Refundable)	\$500	One time, due at move-in	Required if conditionally approved
