Bus service Terms and conditions

Book a 2025/26 tenancy with Winfield Court for September 2025 move in and receive free travel on our dedicated Winfield Court bus service.

Bus pass will be issued once resident has counter signed their agreement, paid their first rent instalment and moved in.

Terms and conditions:

1. **Bus route** - The shuttle bus route includes the following stops:
 - Winfield Court (///logo.potato.splice)
 - Dryden Street – Nottingham Trent University (///funded.firmly.gloves)
 - Jubilee Campus – University of Nottingham (///mock.gold.ridge)
 - East Drive Bus Bay – University of Nottingham (///focus.giving.ranked)
 - Clifton Campus – Nottingham Trent University (///doing.stable.yours)

Please note that the route is subject to change.

Bus service is only available to residents of Winfield Court.

2. **Operating hours** - The shuttle bus will operate between the hours of 08:00 and 17:00 daily during university term time only. There will be no service between 12:30 and 13:30. Operating hours are subject to change.
3. **Ticketing** - Each resident of Winfield Court is entitled to one entry per journey on the shuttle bus. A valid ticket in the form of a QR code must be presented to board the bus. QR codes will be provided upon check-in at Winfield Court. Each weekday during term time your QR code will entitle you to one journey to university and one journey back to Winfield Court.

Only original QR code provided by Winfield Court will be accepted – no copies and no screenshots will be accepted.

Only residents of Winfield Court are permitted to use the bus service, no friends or visitors are permitted. The QR code may only be used by the resident it was issued to and is not transferrable to others.

4. **Conduct** - Winfield Court reserves the right to cancel individual tickets if a resident's behaviour does not comply with our Anti-Social Behaviour Policy or if the shuttle service is misused.

There is no smoking/vaping or drinking alcohol on the bus.

Residents must adhere to the rules and health and safety guidance set by Sharpes of Nottingham (the bus company) including the wearing of seat belts.

Verbal or physical abuse towards the driver or other residents will not be tolerated and will result in the bus pass being revoked.

No large items such as furniture are permitted to be brought on the bus.

5. **Availability** -The shuttle bus operates on a first-come, first-served basis for each journey. Seating and availability are not guaranteed.
6. **Complimentary service** - The shuttle bus is offered as a complimentary service to all residents of Winfield Court. There is no cash alternative or refund for residents who choose not to use the service.
7. **Unforeseen circumstances**

Winfield Court not being liable for alternative transport should the bus be unavailable due to unforeseen circumstances including to but limited to inclement weather, road closures or staff absence.

In the event of the bus being involved in an accident or if there is any injury onboard the bus, Fresh will not be liable and residents travel at their own risk.

By using the shuttle bus service, you agree to comply with these terms and conditions.

The offer is as stated, and no alternatives will be offered. The offer is not transferable.
